## CORRIGENDUM

**(Against Tender for Procurement of Four Colour Offset Printing Machine Sheet Fed Straight/Perfecting or both)**

After the decision made in the Pre-Bid Meeting between Purchaser & Bidders held on 20-07-2020, the following amendments in the Bidding Documents are made:

### Para-1 of Invitation to Bid (Tender)

<b>Existing Entry:</b>	Survey of Pakistan a <u>National Surveying &amp; Mapping Organization</u> , invites sealed bids from <u>Authorized Distributors/Suppliers/Contractors having Agency Agreement with original manufactures</u> , registered with Income Tax & Sales Tax Department and who are on Active Taxpayers List of the Federal Board of Revenue for supply of following Printing Machine.
<b>Read As:</b>	Survey of Pakistan a <u>National Surveying &amp; Mapping Organization</u> , invites sealed bids from the <u>original manufactures having their Sole Agent which have agency agreement with foreign manufactures/Suppliers/Contractors etc.</u> , registered with Income Tax & Sales Tax Department and who are on Active Taxpayers List of the Federal Board of Revenue for supply of following Printing Machine.

### Clause-10 of Part-B Terms & Conditions

<b>Existing Entry:</b>	Maximum period of 6 months
<b>Read As:</b>	Maximum period of 7 months

The rate of exchange shall be selling rate, prevailing on the date of opening of financial bids as notified by State Bank of Pakistan on that day.

<b>Clause-7 Delivery Period of Contract</b>	
<b>Existing Entry:</b>	Or FOR Basis, Rawalpindi within a maximum period of Six (06) months.
<b>Read As:</b>	Within a maximum period of Seven (07) months.
<b>Clause-9 (c) of Contract</b>	
<b>Existing Entry:</b>	Relevant chemicals of machine for the first time operation will be provided by supplier. Moreover, one complete spare set of Rollers along with accessories for one unit will also be provided by the supplier.
<b>Read As:</b>	One complete spare set of Rollers along with accessories for one unit will also be provided by the supplier.

<b>Read As:</b>	Business Experience in Pakistan (20 marks).
<b>Serial-8 of Evaluation Criteria</b>	
<b>Existing Entry:</b>	Income Tax paid during last 3 Financial years by Local Suppliers/dealer/Sole Agent/authorized Agent (15 marks).
<b>Read As:</b>	Income Tax paid during last 3 Financial years by Local Suppliers/dealer/Sole Agent/authorized Agent in Pakistan (15 marks).
<b>Serial-9 of Evaluation Criteria</b>	
<b>Existing Entry:</b>	Total business turnover of Local Supplier/dealer/Sole Agent/authorized agent during last 3 Financial Years (15 marks).
<b>Read As:</b>	Total business turnover of Local Supplier/dealer/Sole Agent/authorized agent during last 3 Financial Years in Pakistan (15 marks).

<b>Read As:</b>	<b>10-09-2020 at 10:30</b>
